## List of Tuition Fees for the 2018-2019 Academic Year

- REGISTRATION FEE:** \$175 per student each academic year.
- TECHNOLOGY FEE:** \$125 per student each academic year.
- GRADUATION FEE:** \$50 per graduating 8<sup>th</sup> grader, due at the beginning of 8<sup>th</sup> grade year.
- TUITION CATEGORIES:** There are two categories for tuition charges.

The "Participating Parishioner" rate is granted to families who regularly attend Mass and submit their Mass cards. A family must attend 26 Masses, or 50% of Sunday Masses in an Academic year in order to qualify as a "Participating Parishioner." If a family is registered with another Catholic Parish, that family must complete an "out of Parish form," that needs to be signed by the pastor of the family parish and submitted to the office.

It is understood that families who pay the "Participating" rate acknowledge their obligations to be faithful to the "Precepts of the Catholic Church." This includes Mass attendance and regular contribution to the parish, as financial means allow and individual conscience dictates.

The "Non-Participating/ Non Catholic" rate applies to families who do not practice our Catholic Faith, or do not attend Mass as required by the participating rate.

### PLEASE USE MASS ATTENDANCE CARDS WHEN ATTENDING MASS IN ORDER TO RECEIVE PROPER CREDIT FOR YOUR ATTENDANCE.

Attendance records will be reviewed annually. If records do not show a consistent pattern of attendance, families will be notified and may be moved to the "Non-Participating/ Non- Catholic" rate.

**Continuing in the 2018-2019 Academic Year, all tuition payments will be made through the electronic tuition program, Smart Tuition. This is a mandatory payment method and requires an annual per family processing fee of \$50 to SMART Tuition. Payments can be set up to occur on a 10-month, 11-month, or 12-month cycle.**
